I will speak with Casey\Karl today and have one of his crew to trim any boards that extend over the footing\property line. As far as the grounding wire is concerned I would need to know who removed the grounding wire from the grounding rod initially . I will defer to Casey to determine if anyone from his crew removed it.


Good Morning Mr. Powell,
